# General institutional information

Accreditation and licensure of institution and programs

Capella University is accredited by the Higher Learning Commission (hlcommission.org), a regional accreditation agency recognized by the U.S. Department of Education.

In addition to our regional accreditation, Capella has achieved specialized and program-specific accreditations.

Capella University is registered as a private institution with the Minnesota Office of Higher Education and is an approved institutional participant in the National Council for State Authorization Reciprocity Agreements (NC-SARA). Capella is authorized to operate in all SARA-member states and is registered, or authorized to operate in states not participating in SARA, or as required based on Capella's activities in states that fall under the jurisdiction of the respective state educational agency. Legal & Regulatory Information.

Upon request, Capella will provide students or prospective students with a copy of accreditation and licensure documents.

# Family Education Rights and Privacy Act (FERPA)

Capella University complies with the provisions of <u>FERPA of 1974</u>, which regulates the confidentiality of data in education records and terms for its disclosure. Capella has a department dedicated to ensuring compliance with the act, and creating relevant policies and procedures regarding the release of student education records and related information under the act.

#### **Career Center**

#### Course materials

Capella partners with VitalSource and Ambassador for the delivery of course materials, which could include eBooks, textbooks, scholarly articles, interactive media, course-specific software, course packs, and other instructional materials.

# **Three-day cancellation**

An applicant who provides written notice of cancellation within three days (excluding Saturday, Sunday, and federal and state holidays) of signing an enrollment agreement is entitled to a refund of the application fee. The school will provide a 100% refund within 30 days of receiving the notice of cancellation.

# Academics

#### **Academic programs**

Capella University offers certificates and bachelor's, master's, and doctoral degrees. There are 53 degree program offerings and 138 specializations as of Sept. 30, 2018.

#### Residency

Capella University students in certain graduate-level programs are required to attend residencies, which are in-person learning experiences that provide face-to-face interaction between faculty and students.

#### **Tuition and fees**

#### Capella scholarships and grants

#### Federal Supplemental Educational Opportunity Grant (FSEOG)

FSEOG recipients must have applied for a Capella scholarship for an eligible program and meet other eligibility requirements. The grants are awarded to Pell recipients who have demonstrated exceptional financial need based on the expected family contribution provided by completing the Free Application for Federal Student Aid (FAFSA). The award amount depends on your financial need. The FSEOG is considered to be gift aid; therefore, it does not have to be repaid.

# **Federal Work-Study Program**

Capella participates in the Federal Work-Study Program, which provides part-time employment to eligible students who demonstrate financial need. Financial need is based on the expected family contribution, which is determined by completing the FAFSA. Federal Work-Study funds are a part of the financial aid package; however, they are paid to students biweekly after they meet employment requirements and earn a wage.

#### **Private education loans**

Private education loans are available to students who are ineligible for federal financial aid or find that federal financial aid does not cover their full education costs. Students are encouraged to apply for federal financial aid prior to considering private education loans. Federal financial aid program terms and conditions may be more favorable than private education loans. For additional information, contact a financial aid advisor at 1.888.CAPELLA (1.888.227.3552). All private loans will be processed accordingly. Self-certification forms are available and will be completed upon request.

#### Disbursements and federal aid refunds

Students who are in the GuidedPath format, eligible for financial aid, enrolled at least half time (for federal loans), and have engaged in their course(s) will have their funds disbursed to Capella during the third week of their course(s). Students in the FlexPath format will have their funds disbursed within the fourth to fifth week of each 12-week billing session. After applying funds to a student's balance, Capella will process a federal aid refund (if applicable) within seven business days.

Once the refund has been processed, it will take three to five business days for Capella to disburse the refund by direct deposit or mail. Disbursements made after the third week of courses are processed using the same timelines.

#### **Books and supplies**

Many of Capella's degree programs offer a Resource Kit, which is a flat-rate quarterly fee that covers the cost of eBooks, textbooks, interactive media, software, course packs, and more. For programs that do not offer the Resource Kit, learners will have access to all electronic materials for the first three weeks of class to allow time to purchase full access.

# **Experimental sites initiative (ESI)**

Capella participates in three ESIs, which test the effectiveness of statutory and regulatory flexibility for disbursing Title IV student aid.

ESI Experiment six involves testing the effect of reduced Unsubsidized Direct Loan borrowing limits on graduation and persistence rates. For Capella, this will take the form of a \$2,000 reduction (\$500 per quarter) in the annual unsubsidized eligibility for a select population of students. This is a statutory exemption from the usual regulatory provisions provided by the Department of Education.

The Prior Learner Assessment ESI involves testing the effect of an increase in cost of attendance allowing learners to receive additional Title IV aid toward prior learning assessment (PLA) fees. For Capella, this will take the form of an increase in Title IV eligibility for the exact cost of the PLA fee, which varies by number of credits and career level. FlexPath is excluded from this initiative.

The Competency-Based Education Experiment allows for the disbursement of Title IV aid for direct costs as soon as the learner completes a required number of competencies, regardless of how many weeks of instructional time have elapsed. Disbursements of Title IV funds for indirect costs would be made at regular intervals related to the completion of a certain number of weeks of instruction. FASAP and R2T4 requirements are waived under this experiment.

# **Financial responsibility**

Students can better plan for their future by borrowing responsibly. This begins with borrowing only loan funds that are needed and planning ahead for repayment. For more information regarding the terms of the Direct Loan program, students may review their Master Promissory Note or the Department of Education Student Aid website.

#### **Tuition refund policy**

Students who drop or withdraw from course(s) will have a percentage of tuition and fees refunded in accordance with university policy.

# **Return of Title IV funds procedure**

Under the Department of Education's return of funds regulations, an institution must first determine the amount of Title IV program funds that a student earned. If the student withdraws during the first 60% of any period of enrollment or payment period, the amount of Title IV program funds that the student earned is equal to a pro rata portion of the funds for which the student would otherwise be eligible. If the student withdraws after the 60% threshold, then the student has earned 100% of the Title IV program funds. For FlexPath offerings, which are nonterm, a Title IV return of funds can also be triggered by a period of student nonenrollment that is greater than 25 days and occurs during the course of the FlexPath 12-week billing period if the nonenrollment is not related to an approved leave of absence per Capella University policy. The institution must return to the appropriate Title IV programs, in a specified order, the lesser of (i) the unearned Title IV program funds and (ii) the institutional charges incurred by the student for the period multiplied by the percentage of unearned Title IV program funds. An institution must return the funds no later than 45 days after the date of the institution's determination that a student withdrew.

Undergraduate students will have funds returned in the following order:

- 1. Unsubsidized Direct Loans
- 2. Subsidized Direct Loans
- 3. Federal Grants
- 4. Federal Supplemental Educational Opportunity Grants

Graduate students will have funds returned in the following order:

- 1. Unsubsidized Direct Loans
- 2. Graduate PLUS Loans

#### Defining 60% of a term

Guided Path: The federal formula to calculate 60% takes the number of completed¹ calendar days divided by the total number of calendar days in that term. FlexPath: Due to the fluid timing of FlexPath offerings, the formula for determining the 60% date is based on a projection of course completion time. For example, Capella assumes that a student who completes three program points in 16 weeks would continue to complete points at that rate. For undergraduate students, who need to complete nine program points to complete one payment period, their projected payment period would be a total of 48 weeks.

<sup>1</sup>Completion refers to days in which there is a record of active course participation (posting in the courseroom, submitting tests, etc.). For certain courses (e.g., dissertation), ongoing participation is not tracked in the courseroom and the date of withdrawal is determined by the date of the course drop.

# Timeline for return processing

Capella University calculates the return of Title IV funds no later than 30 days after determining that a student withdrew or stopped participating. The funds are returned to the Title IV program from which they disbursed within 45 days.

The master's in psychology FlexPath option is waived from the return of Title IV funds requirements with participation in the ESI for competency-based education.

# Separation or withdrawal from the university

Students may request an immediate or delayed discontinuation from the university by completing and submitting the discontinuation request form, located on Campus.

#### Financial aid satisfactory academic progress

Students are required to meet and maintain satisfactory academic progress to be eligible for federal financial aid. Failure to meet minimum requirements will result in students being placed on financial aid warning or probation, or becoming ineligible.

#### **Entrance and exit counseling**

Students who request Direct Loans are required to complete the entrance counseling via the StudentLoans.gov website. The counseling provides comprehensive information on the terms and conditions of the loan and the borrower's responsibilities.

Capella notifies students about completing exit counseling once they have dropped below half-time enrollment, withdrawn, or have graduated. Exit counseling helps students understand their rights and responsibilities as a student loan borrower.

#### National student loan data system (NSLDS)

NSLDS is the Department of Education's central database for student financial aid. Students who request and receive student aid are documented by NSLDS. Loans will be accessible to guaranty agencies, lenders, and schools if they are authorized to use the NSLDS system. Students may access this information to see an integrated view of Title IV loans and/or grant information.

## Percentage of students using financial assistance

At Capella, 78% of students use financial aid assistance, including federal financial aid, nonfederal financial aid, scholarships, and alternative loans.<sup>2</sup> Of all undergraduate students, 44% receive Pell Grants.

# Federal financial aid penalties for drug law violations

A student who has been convicted of a drug-related violation under federal or state law can be disqualified for federal financial aid funding.

Those convicted of possessing illegal drugs will lose financial aid eligibility for:

- First offense one year from date of conviction
- Second offense two years from date of conviction
- Third+ offense(s) indefinitely

Those convicted of selling illegal drugs will lose financial aid eligibility for:

- First offense two years from date of conviction
- Second offense indefinitely

# Student outcomes

#### Gainful employment disclosures

Our gainful employment disclosures, found on each program page on capella.edu, provide information regarding program costs, time to completion, occupational codes, and median debt, along with other important data to students and prospective students.

#### Learning and career outcomes

Capella University is committed to offering clear, transparent information about what students can expect from completing one of our programs. #### Advanced education for bachelor's graduates

Twenty to 25% of students who received a bachelor's degree from Capella re-enrolled in a master's program as of Dec. 12, 2017.

#### **Retention rate**

The industry standard for retention rate is based on the percentage of first-time, full-time bachelor's-degree-seeking students from the previous fall quarter who are enrolled in the current fall quarter. Capella University does not serve a large percentage of first-time, full-time undergraduate students. Our most recent retention rate for this population is 50% and is based on a cohort of two students. The university's retention rate for first-time, part-time undergraduate students is 32%.

#### **Graduation rate**

The industry standard for reporting an institution's graduation rate is based on first-time, full-time bachelor's-degree-seeking undergraduates, graduating within four and eight years. Due to the lack of statistical data, Capella did not report the graduation rates for first-time, full-time undergraduate students who received a Pell Grant, students who received a Subsidized Direct Loan (no Pell Grant), and students who did not receive a Pell Grant or a Subsidized Direct Loan.

For the 2018-2019 reporting year, Capella did not have any degree/certificate-seeking undergraduates to report, and therefore the Graduation Rate 150% survey was not applicable. First-time, full-time undergraduate learners make up less than 1% of our fall enrollment. As of Dec. 31, 2018, 86% of Capella students enrolled part time while 14% enrolled full time.

#### **Placement rates**

Capella does not offer job placement services or regularly calculate placement rates. The American Counseling Association's Council for Accreditation of Counseling and Related Educational Programs (CACREP) requires that Capella University report job placement rates for the MS in Marriage and Family Counseling/Therapy, MS in Mental Health Counseling, and MS in School Counseling.<sup>3</sup> The Commission on Accreditation for Marriage and Family Therapy Education of the American Association for Marriage and Family Therapy Education (COAMFTE) requires that Capella University report job placement rates for graduates of the MS in Marriage and Family Counseling/Therapy program.<sup>4</sup> Placement data for these programs are found on:

# **Annual crime statistics**

# **Drug and alcohol awareness**

Capella University is committed to providing a drug- and alcohol-free environment for students, faculty, and employees. The university maintains policies, procedures, and programs to provide information surrounding drug and alcohol awareness. Capella is required to notify the Department of Education within 10 days of an employee's conviction and must take action against an employee within 30 days of a violation of the policy.

# **Sex offender registry**

The Federal Campus Sex Crimes Prevention Act requires that colleges and universities advise the community where law enforcement agency information provided by a state concerning registered sex offenders may be obtained. It also requires sex offenders already required to register in a state to provide notice of each institution of higher education in that state at which the person is employed or is a student.

To learn the identity of registered sex offenders visit the Sex Offender Database. The information provided here is intended to be in compliance with the Crime Awareness and Campus Security Act and is for safety purposes only. It should not be used to intimidate, threaten, or harass. Misuse of this information may result in prosecution.

#### Information for crime victims about disciplinary proceedings

Upon written request from the complainant of any crime of violence or nonforcible sex offense, Capella will disclose the results of any disciplinary actions taken by Capella against the student who is the respondent of such crime or offense. If the complainant is deceased as a result of the crime or offense, the information shall be provided, upon request.

#### **Vaccinations**

As an online university with no physical student campus, Capella generally does not have specific requirements for vaccinations.

However, some Capella programs do require fieldwork at sites that may or may not have their own requirements for vaccinations. Students must comply with the requirements of their fieldwork site. As an example, Oregon regulations require that nursing students with direct patient contact complete and provide, through their university, a criminal background check, proof of immunizations, drug test, health screening and evidence of professional liability insurance prior to clinical placement. The Oregon Health Authority Immunization Requirements are as follows:

- Hepatitis B (Hep B)
- Measles, mumps, and rubella (MMR)
- Tetanus, diphtheria, pertussis (Tdap)
- Varicella
- Recommended but not required—polio
- Recommended but not required—influenza (seasonal flu)

Capella University partners with CastleBranch Inc. to collect, store, and share student immunization, health, criminal backgrounds, and insurance information for these purposes.

# Additional information

Copyright and file sharing

Faculty, staff, and students must comply with federal copyright and trademark laws, such as the Digital Millennium Copyright Act. No one may use Capella information resources and other information technology tools for unauthorized file sharing, posting of copyrighted materials as one's own, or other copyright violations. Copyright infringement can result in civil and criminal penalties.

# Consequences of illegal download

Summary of civil and criminal penalties for violation of federal copyright laws

Copyright infringement is the act of exercising, without permission or legal authority, one or more of the exclusive rights granted to the copyright owner under section 106 of the Copyright Act (Title 17 of the United States Code). These rights include the right to reproduce or distribute a copyrighted work. In the file-sharing context, downloading or uploading substantial parts of a copyrighted work without authority constitutes an infringement. Penalties for copyright infringement include civil and criminal penalties. In general, anyone found liable for civil copyright infringement may be ordered to pay

either actual damages or statutory damages affixed at not less than \$750 and not more than \$30,000 per work infringed. For willful infringement, a court may award up to \$150,000 per work infringed. A court can, in its discretion, also assess costs and attorneys' fees. For details, see Title 17, United States Code, Sections 504, 505. Willful copyright infringement can also result in criminal penalties, including imprisonment of up to five years and fines of up to \$250,000 per offense.
